4. The empanelment letter shall not confer any right to engagement for Assessment and Certification with MSMEs directly in the name of QCI, by the empanelled firm.
5. The empanelled firm or its associates/companies are not allowed to use the name of QCI, its logo, service marks or any document for any purpose without the prior written approval of QCI.
6. The empanelled firm will follow all SOPs as laid down by the ZED Division for the conduct of assessment and certification.
7. QCI reserves the right to cancel the empanelment letter issued and debar the firm if it is discovered that the firm had produced any false information, on continued delivery of unsatisfactory services, insolvency of the company or any other ethical ground as deemed fit by QCI by giving a 7 days prior written notice.
